1. Every POA entered in this show must be measured unless a legible copy of the Permanent Height Card or Official Measurement Card is included with the entries. The exhibitor is responsible for presentation of the pony's permanent height card to the measurement team. Measuring can be accomplished prior to the start of the show. Check with Jan Jones Nolen for exact time and location. Information will be posted at the Horse Show Office and announcements will be made.
2. Classes listed herein as divided by height may be combined if there are fewer than three (3) entries in each division.
3. All Futurity entrants must pay entries for and enter their respective/corresponding OSF classes on the OSF entry forms. Even though you do not need to pay entry fees for the Futurity classes to the OSF, it is mandatory that you also indicate the class number for the futurity class(es) you have entered on the OSF entry form.

### **Miniature Donkey Show/Class specific information:**

1. Miniature Donkey Show will be run in accordance with the "Texas rules". You can obtain TX rules at [www.gcdma.org](http://www.gcdma.org), with the rules for the Miniature Donkeys beginning on page 131.
2. All Miniature Donkeys must be registered within at least one of the following registries/associations: ADMS, IMDR, ACOSA or IMAD.
3. Maximum height for animals entered in the Miniature Donkey classes is 36".
4. Miniature Donkeys must be at least three (3) years old to enter and participate in any/all driving and/or in hand jumping or coon jumping.
5. Eligibility for age specific halter/in hand classes will be determined by the age as of January 1, 2011. Donkeys must be at least six months of age at time of show.
6. Jacks cannot be shown or managed (handled in control of) by Youth 18 & Under.
7. Prizes will be awarded for Champion and Reserve Champion Halter and High Point.
8. Classes to count for High Point awards: 021, 033, 035, 042, 046, 047, 049, 055, 059, 084, 092 & 093.
9. Class # 48: Miniature Donkey Team Driving: Class will be governed by Texas Rules for the Multiple Hitch Driving class, starting on page 41.
