- 4:00 pm - **Exhibition Barrels** (After Draft Horse Show) – Horses entered in Barrel Races Only
6:00 pm – **Youth Pony Barrel Race** (14 Hands & Under)–Youth Riders (12 & Under)
Straight Jackpot. Leadline allowed (horseback or on foot). Ponies 14 hands and under (height will be verified at 5:30pm). Oklahoma State Fair Belt Buckle to winner, ribbons through 6th place. Entry form must be signed by Parent/Legal Guardian or entry will NOT be accepted. Ponies entered may not run in other barrel race classes.
AQHA (non-jackpot entries) will run immediately following pony race (approx. 6:30pm).
7:00pm - **\$1500 Added Open 5D Barrel Race** - AQHA who wish to jackpot will run first in the Open draw.

Entry Fees - No Processing or Late Fees

- Youth Pony Barrel Race: \$ 5.00/per run – 4 Monies paid (1st-\$40/2nd-\$30/3rd-\$20/4th-\$10)
\$1500 Added Open 5D: \$35.00/per run – ½ Second Splits – 80% Payback
Open Senior Sidepot \$15.00/per run – Age 50+ (day of race)
Open Youth Sidepot \$15.00/per run – Age 18 & Under (day of race)
Open Adult Sidepot \$15.00/per run – Age 19-49 (day of race)
Exhibitions: \$ 4.00/per run – First-Come, First-Served, No Pre-Entries
AQHA Approved Classes: \$18.00/per class/per horse (Youth, Amateur, Am Select, Junior & Senior Classes)

Late Entries accepted until 8pm day of show for jackpots only.

Final Draw will be posted 30 minutes before race. Walk ups after draw is posted will run at the bottom of the draw.

AQHA DRESS CODE ENFORCED (Long Sleeves, Hat or Helmet, Boots)

Negative Coggins and Health Papers will be required for **ALL** horses entering State Fair Park and **will be checked at the gate** by State Inspectors...**GUARANTEED (in-state horses included)**.

Also, you will be required to pay at the gate to get into the Fair as do all horse show exhibitors. This year's barrel race falls on Opening Day and features \$2 gate admission per person. Come in the morning and spend the day at the State Fair with the entire family and some friends for only \$2 each!

Check In Reminder...All horses must enter thru Gate 7. This is OPENING weekend for the Fair and at times there may be long lines at the Horse/Livestock Inspection Gate. Please allow plenty of time to go through the process. No refunds will be offered due to delays at the gate.

PRE-ENTRY FORM (POSTMARKED BY SEPTEMBER 1, 2011) will be posted on www.okstatefair.com and www.trikbarrels.com. You may also enter online through Sept 10, 2011 at 9pm thru Equestrian Online Entries @ www.trikbarrels.com. Credit Card entries will not be accepted the day of the race. Entries mailed or hand delivered after the Sept 1 deadline must be paid for by cash or money order. Pre-entries will get the first draw positions available. Pre-entries will be posted on www.trikbarrels.com on Tuesday, September 13, 2011.

Please include copies of current AQHA Membership Cards for Owner & Rider of each horse, as well as copies of Registration Papers. AQHA entries that do not wish to jackpot will run following the Pony Class, but prior to the open. AQHA entries wishing to jackpot will run at the first of the pre-draw for the Open. See flyer for scheduled approx. start times at www.trikbarrels.com. Exhibitions are first-come, first-served day of show. **Entries mailed or received after pre-entry deadline are CASH or MONEY ORDER ONLY, including on-site entries!!! Credit Cards may be used for ONLINE ENTRIES ONLY thru Sept 10th.** Be prepared to show both Health Papers and Coggins at perimeter gate on ALL horses - State Livestock Inspectors will be checking them....guaranteed.
