RULES:

- An exhibitor may show three Market Wethers and three Club Lamb Breeding Ewes for a maximum total of six.
- All market wethers must have lamb's teeth with no visible signs of permanent teeth.
- All ear tags from previous shows must be removed. **No blankets or covers allowed during classification.**
- Minimum weight is 85 pounds with no maximum weight.
- There will be no official weigh-in of market wethers. Scales will be available for weighing. The exhibitor will provide a weight, on the official weight card, to the Superintendent.
- Upon completion of each class, the superintendent will weigh a minimum of the top five wethers. Any wether which has gained more than 5 pounds from the weight listed on the official showing card, will be disqualified.
- Artificial coloring, paint or powder will not be permitted on market lambs.
- The use of hydration utensils and the use of soft muzzles are permitted in the stalls only. Soft muzzles must be removed from the lambs any time they are taken from their stall for any reason. Failure to use hydration utensils and soft muzzles in the stalls will constitute in disqualification.
- All market wethers must be slick shorn above the knees and hocks. Must be shorn, a maximum of two weeks prior to arrival on grounds for classification purposes.
- Market wethers will be divided into weight classes, as evenly as possible, based on the number within each breed by Superintendent.
- Ewe lambs are not eligible to show with Market Wethers, but can compete in Division 1110 Club Lamb Breeding Ewes. Please see that division for rules and entry requirements.
- **Exhibitors must show in clean pressed jeans, clean shirt with collar and club emblem (4-H or FFA). 4-H and FFA jackets are acceptable but not required. T-shirts, tennis shoes, and headwear are not allowed.**
- The following breeds will be offered in the Junior Market Wether Show:
 - Division 1104 Natural Colored
 - Division 1105 Shropshire
 - Division 1106 Southdown
 - Division 1107 Speckle Faced
 - Division 1108 Suffolk
 - Division 1101 Crossbred

- All accounts of owner must be in financial good standing to be eligible to enter the show ring. Any and all monies will be applied to entry and show fees before being applied to exhibitor admission tickets.

ENTRY INFORMATION:

- Owner's W-9 form must be included with entry.
- Entries can be made online or mailed in. Online entries close August 15. Credit Card payments only taken online.

FEES:

- **Required**
 - \$22.50 per head (if postmarked or entered online by August 15)
 - \$45.00 per head (if postmarked after August 15 & by September 1)
- **Additional**
 - Equipment permit - \$30.00
 - Additional Tickets (pre-order for immediate family members) \$7.00 adult single day ticket, \$4.00 child single day ticket (ages 11 – 6) or an Exhibitor Ticket Bundle (4 single day tickets) for \$20.00 if postmarked by September 1, 2011. Also may purchase Season Pass for \$25.00 good for all 11 days.
 - Exhibitor will receive an armband(s) with Junior Entry.
