Please complete the attached Oklahoma Tax Commission State Fair Registration Form 827-O and return it to the Oklahoma Tax Commission (OTC) as soon as possible. This form is separate from your State Fair registration and must be returned directly to the OTC.

- Every vendor must complete Form 827-O for the OTC.
- If you are not selling any product or taxable service, please indicate this on line 4.
- If you hold a valid Oklahoma Sales Tax permit, include your sales tax permit number on line 10.
- Be sure to include a current phone number and email address.
- Vendors must be compliant with Oklahoma state tax laws before attending the fair.
- Further instructions will be emailed to you once your registration is complete.

Notice: Your Sales Tax Return and payment MUST be filed and paid online at oktap.tax.ok.gov. OTC representatives will be on the fairgrounds the first Thursday and the final Saturday and Sunday of the fair to assist with online filing.
